## Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. #### Why we need data

European Road Cargo processes your personal data for the following purposes:

- To inform you about new products and services
- To give you the opportunity to create an account
- Inform you about important developments in transport and logistics

#### Automated decision-making

European Road Cargo makes no decisions based on automated processing of matters that can have (significant) consequences for people. #### How long we store data

European Road Cargo does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. We follow the legal storage term of 7 years for general data.

#### Share with others

European Road Cargo does not sell your data and only provides to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

#### Mapping your website visit (cookies)

European Road Cargo uses technical and functional cookies. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

#### Viewing, Modifying or Deleting Your Personal Data

You have a legal right to view, modify/correct and/or delete any personal data we may hold. You can do this yourself via your personal settings in your account. In addition, you have a legal right to withdraw your permission for us to process your personal data and/or to object to our processing it. You also have a right to data portability. This means that you can send us a request to collate all your personal data

held by us in a computer file and to send it either to you or to any organization you nominate. Should you wish to exercise your right to object and/or to data portability, or should you have any other questions/remarks regarding personal data processing, please send a request to b.houweling@europeanroadcargo.com and include specific detail.

To ensure that any data inspection request you may send actually comes from you, we would ask you to include a copy of the personal ID card with your request. In this copy you should redact, or black out, your pass photo, the MRZ (machine readable zone, which is the strip with the numbers at the bottom of your passport) and your Citizen Service Number (BSN). This is to protect your privacy. European Road Cargo will respond to your request as quickly as possible, but always within four weeks at the latest.
